## **6 June 1944, D-Day**

Our Luncheon in June coincides with the 79<sup>th</sup> Anniversary of the Normandy Invasion, the beginning of the end of World War II. To commemorate this momentous event, we have invited our Companions to share with us their memories of fathers, grandfathers, and distant family members who served on active duty on the day that Historians now call: "**The Longest Day**". These are a few of their stories...



Bob Epstein recalls: "My father, Lt. **Mort Epstein**, was a pilot in one of the 820 C-47s who dropped the paratroopers of the 82<sup>nd</sup> and 101<sup>st</sup> Airborne Divisions on D-Day. Two of my uncles, Sgt. **Henry Goldberg** and Sgt. **Julian Ertz** were tank commanders in the Fourth Armored Division that relieved the 101st Airborne at Bastogne. My third uncle, Lieutenant **Jerry Epstein** was a fighter pilot flying P-38 *Lightnings* and later P-51 *Mustangs* in the Pacific."



Curtis Frisbie recalls: "My Dad, **Curtis L. Frisbie** joined the US Army Air Corps in 1940. He soloed in a PT-17 *Stearman bi-plane*, an open cockpit aircraft with a 220 hp engine. In England, he flew planes loaded with paratroopers or pulled gliders loaded with troops and vehicles. His most memorable mission was as part of the 900-plane formation during Operation Market-Garden, the largest parachute assault operation in the war. He proudly boasted that he never lost a paratrooper or a crewman."



Steve Suiter recalls: "My Dad **Dr. Wilbur L. Davis**, was a Captain in the 82<sup>nd</sup> Airborne Division. He landed in a glider the night before D-Day and set up an Aid Station. He said the next twenty-four hours were a blur, as he treated countless wounded soldiers, from both sides. His Diary was filled with chilling entries, such as: "we lost Sergeant Johnson today". During the final days of the war a platoon of 50+ Germans attempted to surrender to him, but he told them to "just keep moving to the Rear".

**6 June 1944, D-Day**

Marc Liebman recalls: “My father, Captain **Sy Liebman**, was in 34<sup>th</sup> Bomb Squadron, 17<sup>th</sup> Bomb Group, flying Martin B-26 *Marauders*. He had just reported to the squadron when Lt. Col. Jimmy Doolittle arrived asking for volunteers. Since he had *zero hours* in the B-25 *Mitchell*, he was not selected. The 34<sup>th</sup> was the first Squadron to fly *Marauders*. They had no GPS, no satellite data, no accurate weather info, outdated charts and unvalidated aircraft fuel consumption data. They flew across the South Atlantic from Brazil to Ascension Island, then on to Morocco and finally an air base in Algeria. It took the squadron 10 days to make the trip. They arrived two days after Operation Torch, in 1942. He flew 82 combat missions (skip and level bombing), then returned to the U.S. in December 1943.”



Randy Fitzgerald recalls: “My father, First Sergeant **Paul E. Fitzgerald**, fought in all four battles of Monte Cassino in Italy, Jan–May 1944; while 1<sup>st</sup> Sgt. of Battery A of the 985<sup>th</sup> Field Artillery Battalion. He deployed to North Africa 21 Aug. 1943 sailed on the *SS Monterey* from New York. to Oran, French Algeria. On 9 Nov 1943, the 985<sup>th</sup> Field Artillery Battalion was assigned to US II Corps at Pietra Melara, Italy. II Corps consisted of the 34<sup>th</sup> and 36<sup>th</sup> US Infantry Divisions, 1<sup>st</sup> Special Service Force and an Italian Motorized Brigade, under LT GEN Leonard Gerow’s US Fifth Army.



Don Munson recalls “My Dad, **George W. Munson**, served as an ARC Field Director in North Africa’s Western Command in 1942, (Operation Torch). He was transferred to England for the buildup for the Invasion. He missed D-Day by two months, landing in France, in early August.”



Munson also shares this memory: “My neighbor in Coppell, the late Captain **Lee Swofford**, joined the US Army Air Corps in 1939. By D-Day, 1941, he Commanded a squadron of B-17 *Flying Fortress* Bombers. His target was a bridge north of the city of Caen that would have allowed German tanks access to the beachheads. Lee laughed as he told me that 25 years after the war, while reading *The Longest*



*Day*, by Cornelius Ryan, he learned, for the first time, that his bombs had destroyed their target.”

John Wagner recalls: “Capt. **Cleveland H. Pardue, Jr**, MD, was my father-in-law. He was the town physician in Vivian, LA. He joined the Army and was assigned to General Patton’s 3<sup>rd</sup> Army. He arrived in England aboard the *Queen Mary* and was assigned to a Cavalry unit. As a Medic, he was the first to see the combat casualties and *triaged* those who could be saved. If their wounds were too serious, they were made as comfortable as possible and left to die at the battalion Aid Station.”



Last Month’s Program, May 2023

**Lieutenant General Richard Carey (USMC, Ret)** captivated the May luncheon audience from the moment he entered the room. His career is the story of a highly decorated, battle-scarred, true warrior. He enlisted in the US Navy in 1945, became a US Marine in 1948, served in combat in the Korean War, including the landings at Inchon and the [Battle of Chosin Reservoir](#), during which he earned the Silver Star for heroism, while serving as a Company Commander in the 3rd Battalion, 1st Marine Regiment, prior to his medical evacuation to the States after being wounded in action.

During the Vietnam War, he commanded Marine Squadron 13 and later Fighter Attack Squadron 115 (VMA-115) flying the F-4 Phantom, in 1967-68. His awards and decorations include: the Silver Star; two Legion of Merit awards; the Distinguished Flying Cross; two Bronze Stars (for Valor), 15 Air Medals; a Purple Heart; and Commendation Medals from the Joint Chiefs of Staff, the US Navy, and the Department of Defense. His story is told in the book: *The Flying Grunt*, by Alan E. Mesches.

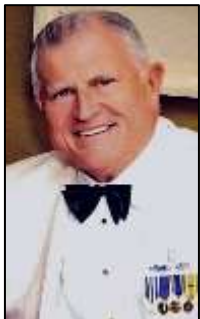

# Your New Chapter Leaders

## Allen C. Clark, Captain, US Army



Allen graduated the United States Military Academy in 1963. He served as a Military Intelligence officer assigned to the 5th Special Forces Group. During an early-morning mortar attack at the Dak To Special Forces camp on June 17, 1967, he sustained injuries in that necessitated the amputation of both legs below his knees. He was awarded a Silver Star for Gallantry in Action, the Purple Heart, and the Combat Infantryman's Badge.

While learning to walk on prosthetic legs, he obtained an MBA in finance and investments from SMU. Allen was an investment manager for Ross Perot; was vice president of a bank; president of three oil service companies; and co-founder of a real estate investment company.

In 1981, Allen was chosen by President Ronald Reagan to be Deputy Administrator for the Veterans Administration. Instead, he chose to remain in Texas where he was the Texas GOP's nomination for State Treasurer. Former Texas State Governor Ann Richards won.

In 1989, President George H.W. Bush nominated him to be Assistant Secretary for Veterans Liaison at the US Department of Veterans Affairs. In 1991, he became Director of the National Cemetery System, a position in which he served until the end of the Bush Administration.

In 1993, the Military Chaplains Association awarded him their annual National Citizenship Award. Allen was then selected by the Disabled American Veterans to be the Outstanding Disabled Veteran of Texas in 2000.

He retired in 2005. His current lay ministry is involved in outreach efforts to help veterans recover emotionally and spiritually from adverse wartime experiences. Allen participates in many community and civic activities, including regularly speaking at various group events and churches. Allen has addressed audiences nationwide as a political candidate, public official, and motivational speaker.

He is a member of the American Legion, Association of the US Army, Disabled American Veterans, Military Order of the World Wars, Military Order of the Purple Heart, Military Officers Association, Sons of the American Revolution, Special Forces Association, Veterans of Foreign Wars, Association of Graduates of the U.S. Military Academy, and Vietnam Veterans of America.

Allen and his wife, Linda, live in Dallas.

## Natan Ton-That, LT, US Army



Natan was born in Da Nang, in Central Vietnam, on *Veterans Day*, November 11, 1967. His name means "A Gift from God". His father was a chief mechanic for the US Navy Seabees in Da Nang.

After the fall of the Republic of South Vietnam on April 30<sup>th</sup>, 1975, the local Communist leaders in Da Nang, who knew of his father's connections to the US military, confiscated his business, his property, his money, his tools, and his permit to travel.

After 3 years under gruesome rule by the North Vietnamese Communists, his father planned an expensive and dangerous escape to freedom, by boat. By the grace of God, the dozen families in the boat survived a vicious monsoon storm in the South China Sea and were rescued by Chinese fishermen, who transported them to Hong Kong.

With the assistance of the Catholic Church, his family located a distant relative living in America, who agreed to be their sponsor. After spending more than six months in a refugee camp in Hong Kong, they arrived in Denver, Colorado. Two weeks later, his father was offered work as an airplane mechanic, in Wichita, Kansas.

Kansas became home, starting in 1979. Natan completed primary and secondary school education there, and then earned a Bachelor of Arts degree in history at Wichita State University. While taking courses to earn a Master's degree, he volunteered for the Peace Corps to " *repay America.*" He spent two years in Hungary with the Peace Corps, and then returned to Kansas and completed his Master's program earning a degree in History.

In the winter of 1995, Natan enlisted in the US Army Reserves. After completion of Advanced Individual Training at Fort Sam Houston, in San Antonio, he received a direct commission as a Second Lieutenant.

He was inducted into the Dallas Chapter of the Military Order of World Wars in 2020. His work ethic and enthusiasm became immediately apparent to the officers of the chapter. He was elected to be the Junior Vice Commander in his second year as a Companion. This month, he will be installed as our Senior Vice Commander in preparation for becoming the Commander of the Best Chapter in the Nation, in 2024.

# National Defense and Homeland Security

## House Oversight and Accountability Report Insights

Some of our country's most respected and trusted institutions are being investigated for massive corruption at the highest levels of their leadership.



Over the past several years, bias seems to have crept into our intelligence analysis process, as more intelligence displays a political leaning. One of the reasons we have so many intelligence agencies is to prevent bias in the analysis, especially political bias. Intelligence is supposed to be fact based.

If intelligence analysts have political bias in their analysis, they could sway decision makers into making incorrect decisions, either intentionally or unintentionally, as the data has been slanted to a particular political direction. This is dangerous for the intelligence community (IC), the public, and policymakers. Bias undermines the benefits of intelligence as a force multiplier and leads to distrust of the IC in the eyes of policymakers and the public.

Before the Internet age, print, radio, television, and newspaper media had time to investigate decisions, policies, facts, or issues. Since the Internet age began, news is almost instantaneous, and facts are less important than publishing the story quickly. Before the Internet, reporters had time to investigate stories. Today, opinions seem to outweigh facts and speed seems to be more important than accuracy.

Top-level leaders in the CIA, FBI, Department of Justice (DOJ), and media have been compromised by bias. It is strategically vital for US intelligence personnel to analyze facts without bias. A republic cannot exist without a well-informed citizenry and a country cannot remain dominant without well informed decision makers.

The House Oversight and Accountability Committee (HOAC) recently disclosed documents which show that FBI and DOJ leaders withheld information about the Biden family and their associates. Most mainstream media did not cover the HOAC press conference.

His family has received payments in excess of \$10 million from foreign individuals and companies.

The Oversight Committee severely condemned the DOJ, FBI, CIA, and the media as they possessed this information during the 2020 Presidential election and failed to disclose it. Former Deputy CIA Director Michael Morrell is known to have solicited *CIA* support for Joe Biden.



The report further says 51 CIA leaders stated that the laptop owned by the candidate's son was Russian disinformation -- when they knew it was not. Former CIA Director John Brennan testified as such during sworn testimony to the House Judiciary Committee. John Ratcliffe, former Director of National Intelligence, stated that none of the 51 former CIA executives had access to any information concerning the laptop when they stated that the laptop "... has all the classic earmarks of a Russian information operation." (19 OCT 2020).

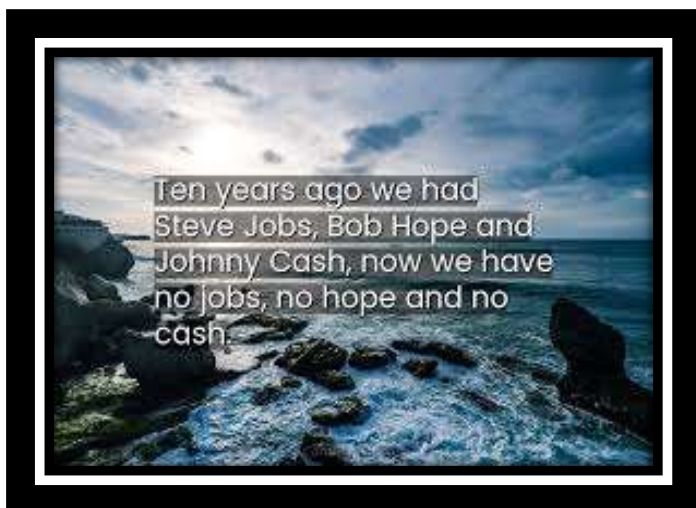
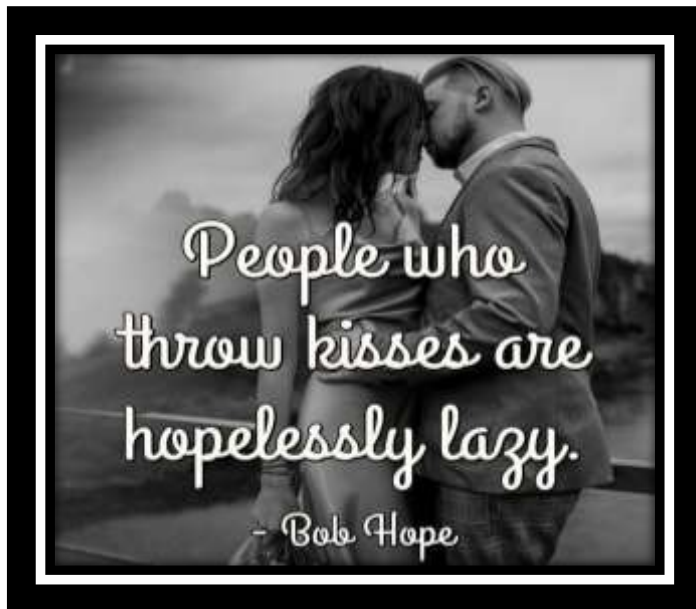
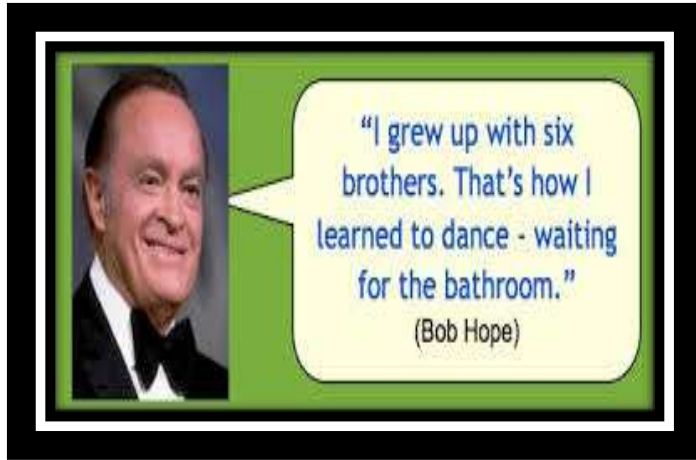
The media and others then used the CIA statement -- that was known to be false -- to accuse President Trump of misrepresenting the facts about the laptop, which has information on it showing Biden family members engaged in multiple unethical and arguably illegal activities.

The FBI and DOJ were in possession of the laptop two years before the House Oversight and Accountability Committee reviewed the materials. One hundred seventy Suspicious Activity Reports (SARs) were issued by the four financial institutions mentioned in the laptop. Federal laws require financial institutions to file an SAR if money laundering, racketeering, or tax evasion is suspected.

Until trust and credibility are restored in the CIA, FBI, DOJ, and the mainstream media, the US republic is in danger. The FBI has been weaponized for political retaliation to serve a political agenda. Faith in the US government and its institutions are diminishing both at home and abroad.

Many citizens believe America has a dual system of justice and no longer trust the CIA, FBI, DOJ, or the media. Perhaps the 51 former CIA officers, who chose bias over facts, and still have security clearances, should lose them. And please explain why some of those Pulitzer Prizes for "Excellence in Journalism" should not be rescinded.

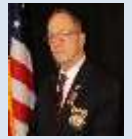
